To Whom It May Concern,

I would like to take this opportunity to thank you for allowing the Suffern Fire Department to comment on the potential impact(s) that the IV2 Rockland Logistics Warehouse Center may have on our department. Listed below are the answers to the questions from the letter dated August 23, 2022.

- The Suffern Fire Department is professionally staffed by volunteers, with no paid employees. At the present time, we have 115 rostered members, of which approximately 50 are active in firefighting duties.
- 2. The Suffern Fire Department fleet of vehicles consist of the following:
  - a. Chief Response Vehicle = 3 (1) 2019 Chevrolet Tahoe and (2) 2021 Chevrolet Tahoe
  - Engines = 3 (1) 2005 Seagrave 2000 gpm pumper, (1) 2009 Seagrave 1500 gpm pumper and (1) 2021 Seagrave 1500 gpm pumper
  - c. Aerials = 2 (1) 2002 Sutphen 95' Platform and (1) 2010 Seagrave Tractor Drawn Aerial
  - d. Rescue = 1 2015 Spartan ERV Heavy Rescue
  - e. Utility Vehicles = 2 (1) 2006 Ford F350 and (1) 2008 Ford F450 with utility body
  - f. Specialized Vehicles = 2 (1) 1962 Dodge Brush Truck and (1) 2022 Polaris 4x4 Side-by-Side with firefighting pump and rescue sked (This unit has not yet been delivered)
  - g. Boat = 1 2012 AB Inflatables "Zodiac" with motor
- 3. The estimated response time for a Chief to arrive at the subject property based on day and time of day is 4-6 minutes. Apparatus arrival is shortly thereafter.
- 4. Our total calls for service in the years 2019, 2020, and 2021 are as follows:
  - a. 2019 = 347
  - b. 2020 = 337
  - c. 2021 = 322
- 5. There are currently no proposed improvements to the Fire Department. Our 2002 95' Sutphen Platform aerial is the next apparatus slated for replacement, which is dependent on funding. This piece of equipment is our first-due apparatus to this facility.
- 6. The Suffern Fire Department currently maintains an ISO rating of 3.

- 7. As with all fire departments within New York State, we participate in the New York State Mutual Aid Plan. In addition, we are participants of the Rockland County Mutual Aid plan. There are currently no specific mutual-aid plans for this facility.
- 8. As stated above, our 2002 Sutphen 95' platform is our first-due apparatus to the subject property. The current apparatus will not meet the needs of the proposed facilities for several reasons; turning radius, fire-pump capacity, and aerial operations are just a few. Without the proper aerial device, no firefighting operation will be successful in mitigating damage to the entire building.

Lastly, contrary to what the letter states, the rank and file of the Suffern Fire Department has not been afforded the opportunity to meet with the project team. I would request a meeting with the team, which is to include the property developer as well. Good Afternoon Ms. Rudow,

I am writing this email in response to your letter requesting information from the Suffern Police Department for the purposes of preparing an environmental impact statement for the above project. Please see the below responses:

1. Number of personnel in the Suffern Police Department- The Suffern Police Department currently employs 35 persons, including 22 sworn full time police officers, 6 sworn part time police officers, and various civilian staff.

2. Response time to the Subject Property- Response times can vary, but our average response time to emergency calls for service is under 2 minutes.

3. The number and types of equipment available- 16 marked and unmarked police and special purpose vehicles, UAV (Drone), K9 Unit.

4. The total number and types of calls received in 2020 and 2021 (or most recent two years available)- 2020- 7625 calls for service; 2021- 9704 calls for service; 2022- On pace for 10,500 calls for service. Call types vary, but include motor vehicle accidents, domestic disputes, disorderly persons, burglary, assault (physical and sexual), medical calls, fire calls, suspicious incidents and persons, 911 calls, animal complaints, alarms, civil disputes, emotionally disturbed persons, fights, hazardous conditions, intoxicated persons, larcenies, missing persons, noise complaints, welfare checks, etc.

5. Any proposed improvements or updates contemplated for the Suffern Police Department- None at this time

6. Any additional information that you believe to be relevant to the environmental review- It should be noted that a warehouse facility of this size will likely increase the calls for service and total workload for the police department. I would expect a heavy commercial vehicle volume increase, as well as general calls for service including motor vehicle accidents, medical calls, alarms, etc. As part of the review, an increase of police staffing levels should be reviewed and considered.
